PURPOSE

1.1 To submit a report as provided for in terms of Regulation 5(3) of the Regulations promulgated under the MLRA, with regard to to appeals by 14 Appellants in the West Coast Rock Lobster Offshore fishery ("the Appellants").

2. GROUNDS OF APPEAL

2.1 The grounds of appeal by 14 Appellants relates to their exclusion. The Appellant alleges that it was informed by the Departmental officials that no one will be excluded on the basis of being a Co-operative, as such it was misled. It argues that based on this, it is entitled to be refunded its application fee.

3. DELIBERATIONS

3.1 The Appellant was a Category C applicant. Category C applicants were classified as those applicants who have never before held fishing rights in any of the commercial fishery sectors of South Africa. The Appellant was assessed and was subsequently excluded for improperly lodged application, in that, it is not a registered South African company or close corporation as stipulated in section 5.1 of the Policy on the Allocation and Management of Commercial Fishing Rights in the Hake Inshore Trawl Fishery: 2015 ("the Sector Specific Policy").

3.2 Section 10 of the Sector Specific Policy stipulates that the application fee is non-refundable.
