2015/16 FISHING RIGHTS ALLOCATION PROCESS: SUITABLE VESSELS
TO BE CONFIRMED OR NOMINATED IN THE LARGE PELAGIC LONGLINE
FISHERY

Cape Town: Thursday; 02 February 2017: In accordance with the General Published Reasons for the decisions on the allocation of 2015/16 Fishing Rights and Effort in the Large Pelagic Longline fishery ("the GPR"), no successful applicant will be permitted to utilise more than two suitable vessels in the Large Pelagic Longline fishery. As such, successful applicants that have nominated more than two suitable vessels are required to confirm their preferred suitable vessels. In accordance with the Public Notice issued on 31 January 2017 on the Final list of Fishing Rights Allocation Process 2015/16 for the Large Pelagic Longline fishery ("the Public Notice"), only the above-mentioned applicants are required to provide written notification to the Department regarding their preferred two suitable vessels.

Successful applicants who did not nominate either a vessel or a suitable vessel will be required to nominate their suitable vessel by providing written notification to the Department as stipulated in the GPR and the Public Notice. For ease or reference, a list of all applicants (successful and unsuccessful), together with their nominated suitable vessel(s) is attached hereto and marked as Appendix A.
