INVITATION TO APPLY FOR PERMITS TO UNDERTAKE BOAT BASED WHALE AND DOLPHIN WATCHING AND WHITE SHARK CAGE DIVING OPERATIONS IN TERMS OF THE THREATENED OR PROTECTED MARINE SPECIES REGULATIONS

The Chief Director: Specialist Monitoring Services of the Department of Environmental Affairs hereby invites applications for permits to conduct a:

- White Shark Cage Diving (WSCD) operation; and/or
- Boat Based Whale and Dolphin Watching (BBWW) operation

The permits will be allocated in terms of National Environmental Management: Biodiversity Act 2004 (Act No. 10 of 2004) read together with the Threatened or Protected Marine Species Regulations in *Government Gazette* 40876 of 30 May 2017 as well as the following Policies:

- Policy for the Management of White Shark Cage Diving; and
- Policy on Boat Based Whale and Dolphin Watching in *Government Gazette* 40878 of 31 May 2017.

3.3. Applications for a Boat Based Whale Watching Permit at St Lucia or Sodwana Bay

Applicants applying for a boat based whale and dolphin watching permit for St Lucia or Sodwana Bay must submit a separate application for a concession to operate within the iSimangaliso Wetland Park. Application forms for the concession are obtainable from iSimangaliso Wetland Park Authority by emailing bids@iSimangaliso.com. Applicants applying for BBWW permit for St Lucia or Sodwana Bay must submit applicable concession issued by the iSimangaliso Wetland Park Authority or proof of application for a concession to operate within the Park. Applications for a concession to operate within the park will be evaluated and assessed by the iSimangaliso Wetland Park Authority.

No white shark cage diving permits will be issued in the iSimangaliso Wetland Park.

Any application for a permit regardless of the area applied for will be distributed and accepted at all centres including Sodwana Bay. Applications for a concession to operate within the iSimangaliso Wetland Park will **only** be distributed and received by iSimangaliso Wetland Park Authority.

3.4. Application Fees

Applicants will be required to pay an application fee of R9123.00.00 for a BBWW and/or WSCD application as indicated in the Threatened or Protected Marine Species Regulations. Applicants must quote their Company name as the reference number at the time of payment. Proof of payment must be attached to the application form when it is submitted. Application forms without a proof of payment attached will not be processed.

Applicants must submit a separate application form for each area applied for but will only be required to pay <u>one</u> application fee regardless of the number of applications submitted in a particular sector. Applicants applying for both BBWW and WSCD permits will be required to pay the application fee for each sector. Where more than one application is submitted in the same sector, the Company name must be quoted as a reference for payment.

ADDITIONAL APPLICATION FEES FOR CONCESSION TO OPERATE WITHIN THE ISIMANGALISO WETLAND PARK WILL APPLY

APPLICATION FEES ARE NON-REFUNDABLE

APPLICATION FORMS WILL ONLY BE DISTRIBUTED AND RECEIPTED AS STATED ABOVE.
