Land

- Mapping all land parcels of those who are interested in venturing and or supporting the Biodiversity Economy space and the GBF 30x30
- Develop a database for the willing landowners and willing projects and enterprises.
- Research and further identify the use and role of the available land in the biodiversity sector, e.g strategic water source areas etc.







Financing

- Map all available finance Mechanisms (funding , Finance, and investment landscape)
- Tailor-made funding mechanisms for the biodiversity sector.
- Mobilization of finances using all available tools
- Develop mechanisms to access "at scale finance" to support biodiversity e.g. Grants, "green fund" Debt for nature, payment of ecosystem services, etc
- Continuous pitching and matching investors and investees
- Bringing in new biodiversity projects and packaging the same on Investment Portal
- The National Capital Accounting for the Sector.
- Explore various Incentives for the Sector.







One-stop-shop

- Establish a one stop shop, services and develop the model. Maybe look at BIOPANZA for the entire sector and not a stream
- A sustainable network of value chain players who could support businesses from ideation, proposal development,
- Look at institutions that should comprise the One Stop Shop
- Link enterprises with appropriate partners on training , finance etc
- Thorough feasibility studies and business plans for biodiversity opportunities
- Continuous conversion of the sector players
