### INTRODUCTION

- Established in the early 1990's.
- Following conflict that arose around a case docket... affected stakeholders were invited to a meeting around a three legged pot over a fire at Swartkops Inspection Quarters.
- This hot meeting evolved into the Environmental Crime Task Team (ECTT). The membership rapidly grew and involved representation from the SAPS specialized units and the National Prosecuting Authority
- The meetings were held quarterly and the venues rotated throughout the province in the provincial protected areas.
- The initial focus was on green matters, quarterly meetings

### INTRODUCTION

- The ECTT evolved into the current Eastern Cape Environmental Crime Working Group (ECECWG), after the establishment of the "Environmental Management Inspectorate"
- With the name change the focus also changed to include brown and blue environmental crimes.
- The attendees increased as other Organs of State with an environmental mandate were invited and began to contribute.
- Other Provinces visited the ECECWG to emulate the concept in their provinces.
- The DPP and Provincial Commissioner of SAPS gave their full support
- Has been meeting quarterly, consistently since inception as a WG in 2007

# PURPOSE OF THE FORUM/HISTORY/REASONS WHY IT WAS ESTABLISHED

- Co-ordinate responses to alleged environmental crime between different Organs of State that had a concurrent environmental enforcement mandate.
- Provide a forum where challenges related to prosecution were discussed and investigative techniques improved.
- Provide a conduit for Working Group IV and other environmental crime related initiatives
- Building camaraderie and teamwork!



# Strategic importance/ significance in dealing with environmental crimes

- Collaboration platform with law enforcement role players
- Information sharing intelligence for operations
- Augmenting capacity through joint effort
- Reporting platform for progress on prosecutions DPP & the NPA
- Awareness of environmental crime building role-player confidence

### **ACHIEVEMENTS**

### Early days:

- Smuggling; birds, cycads, rhino products...
- Protected species poaching... kudu, buffalo theft...

#### • ECECWG:

- Rhino prosecutions, (100 years per suspect plus.)
- Cycad prosecutions, (10 years direct imprisonment.)
- Succulents, Clivias,...
- Racketeering certificates for cycads and clivias. (First in RSA.)
- Municipal Manager prosecution, (Maletswai and Cradock.) Another first in RSA.
- Demolition of unlawful structures consequent to administrative actions.

- Greater involvement of SAPS Crime Intelligence.
