- 1. Any person applying for a licence for the purpose of operating a boat launching site under regulation 7 must complete this application form. This application form must be completed in full. This application form requires the minimum information for the consideration of an application. Should an applicant believe it necessary, further information may be attached to this application as clearly marked annexures. Only the original completed, signed and dated application form will be accepted; a faxed or e-mailed version thereof will not be accepted.
- 2. The submission of this application form must be accompanied by the stipulated application fee which is R5000 (Five thousand Rand) per boat launching site per maximum period of 60 months (5 years). In order to facilitate payment, you are advised to contact the Department telephonically, to obtain a reference number before depositing the stipulated application fee.

- Step 4: Attach proof of payment (e.g. copy of bank deposit slip or other receipt) to the application form.
- 3. Any information required as annexures or attachments to this application MUST be provided. Failure to do so may result in the application being refused. In considering an application for exemption, the Department is under no obligation to seek out or request further information so as to consider an application.
- 4. The following proof and/or documentation must be provided. Failure to provide this information could result in the application being rejected.
- 4.1 Proof indicating that the person applying on behalf of the authority responsible for managing and controlling access to the launch site is duly authorised to make such an application, if the applicant is not such responsible authority.
- 4.2 A detailed Locality Map or copy thereof (1:50 000) which clearly shows the boat-launching site in relation to the surrounding area with the intended location of the boat launching site clearly indicated.
- 4.3 A detailed Site Plan of the proposed boat launching site clearly indicating existing infrastructure and layout, boundaries, vehicle access points (from roads or parking areas), parking areas, vehicle routes, etc.:
- 4.4 A copy of the Lease Agreement granted for the boat launching site under the Sea Shore Act (No. 21 of 1935) if existing.
- 4.5 Photographs of the boat launching site and its surroundings (if available, please also provide a recent aerial photograph).
- 4.6 An environmental assessment undertaken in accordance with section 24(5) of the National Environmental Management Act (see Part C below); and
- 4.7 An Environmental Management Plan (see Part C below);

- 4.8 If the boat launching site's infrastructure was approved by the relevant provincial environmental authority in terms of the Environment Conservation Act (Act No. 73 of 1989) and the amended EIA Regulations (Government Notice No. 670 of 10 May 2002), please provide a copy of the Record of Decision.
- 5. This application must be completed and signed by the applicant. The applicant's signature must be commissioned by a Commissioner of Oaths. If the application is completed by a third party (such as a consultant or legal representative), then this third party's details must also be provided as required in this application. PART C: COMPLIANCE WITH SECTION 24(5) OF NEMA

Unless you are suitably qualified and competent to complete the following you must appoint an independent consultant to undertake the investigation and other procedures necessary.

- 1 Applicants must carry out an environmental impact assessment (EIA) in order to comply with the requirements of section 24(5) of the National Environmental Management Act relating to the investigation, assessment and communication of the potential impact of the activities associated with boat launching at the site. These requirements are set out in Annexure 1 which is attached to this application form.
- 2 In complying with the requirements of the Act, applicants must demonstrate that:
 - 2.1 environmental factors been taken into account in the planning, site-layout and access route to the launch site; and
 - 2.2 impacts associated with erosion have been taken into account in respect of the boat launching site location and vehicle access route(s) alignment.
- 3 If 2.1 and 2.2 above have not been complied with in respect of existing boat launching sites, then applicants must nevertheless demonstrate that:
 - 3.1 maintaining the existing boat launching site(s) will result in less significant environmental impact than establishing alternative boat launching site(s); and
 - 3.2 appropriate measures, as necessary, will be adopted to ensure that continued use of the site will not result in significant negative environmental impacts.
- 4 Applicants must submit an environmental management plan (EMP) for the proposed boat launching site. This EMP must provide details in respect of:

measures adopted to minimise impacts associated with vehicle use in the boat launching site; measures taken to control vehicle access to the boat launching site;

how vehicle use will be regulated in the boat launching site, including safety measures applicable to other users of the coastal zone:

measures taken to ensure compliance by vehicle users with general fishing permit conditions and the provisions of the MRLA; and

initiatives to be undertaken to ensure compliance and proper and reliable monitoring of impacts on the environment:

measures taken to ensure the removal of waste/refuse from the site; and emergency procedures in the event of a spillage of oil or petrol.

5 The EMP must be informed by the EIA for the site. Read with the EIA, the EMP must demonstrate that the intended vehicle use in the boat launching site will not cause significant harm to the coastal zone.

PART D: OTHER LEGAL REQUIREMENTS

Please note that compliance with the requirements of section 24(4) of the National Environmental Management Act and the issuing of a boat launching site licence does not absolve the applicant or users of the site from complying with the requirements of other legislation concerning the establishment and operation of a boat launching site. Such legislation includes the Sea Shore Act (No. 21 of 1935), the Marine Living Resources Act (No. 18 of 1998), the Lake Areas Development Act (No. 39 of 1975) and any regulations concerning safety and navigation requirements applying to boat use.
