# Background

In 2012 at the 5<sup>th</sup> People & Parks Conference:

- 1. The Commission reported that: there are 158 land claims on protected nature conservation areas, 45 of which had been settled (through section 42D), 3 dismissed and 3 in court;
- 2. The Commission reported on challenges that it faced in the settlement of claims in conservation areas and proposed to develop tools to assist its officials;
- The Commission committed to developing joint settlement plan 3. (between Commission, Management Authorities and Communities) and hold joint meetings to monitor implementation of the plans;
- 4. The Commission committed to transferring land in 5 claims per Province.



# **Progress since 5th People & Parks Conference**

- Guidelines for processing claims on state land were developed  $\bullet$ and a step by step process flow was developed.
- A nature conservation specific business plan was developed.
- Joint Provincial Action plans were developed and joint meetings were held to monitor the implementation of the plans.
- The Recapitalisation and Development Programme Framework was amended
- A total of 42 projects were identified where properties were to be transferred

# **Progress since 5th People & Parks Conference**

- To date 15 projects have properties transferred
- 7 claims have been settled through financial compensation
- 2 claims have been dismissed
- 18 claims remain outstanding, however plans to have properties transferred are in place.

# Way Forward

- The Surveyors General are currently surveying unserveryed and unregistered state land, especially in the former Transkei and Bophuthatswana. This will enable the registration of properties on that land.
- The communal land tenure policy will be finalised in the current calendar year, unlocking claims on Ingonyama Trust Land.
- The co-management will be implemented in line with the Rural Economy Transformation Model, the Institutional Roles and Role-Relationship referred to in that model, adopted by the Department of Rural Development and Land Reform.

# Way Forward

- It is envisaged that the co-management structures shall be partly resourced, during the first 5-year period of existence, through the allocation of departmental Recapitalisation and Development Programme (RADP) funds.
- The allocation of these funds will be based on adequate needs assessments undertaken within these areas and appropriate resource allocations linked thereto.
- This will ensure that adequate institutional support is provided during the period of government assistance, and that institutions are therefore strengthened and capacitated during this same period to undertake their respective mandates post termination of support by the DRDLR.



- DRDLR will continue to engage with Environmental Affairs through joint committee meetings to prioritise the finalisation of these claims on conversation land.
- We will use the lessons learned in settling the 5 prioritised claims so that we can move South Africa forward in collaboration with communities for a sustainable vibrant equitable rural communities.
