**NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998)****CONSULTATION ON THE INTENTION TO ADOPT THE NATIONAL WEB BASED ENVIRONMENTAL SCREENING TOOL AS AN ENVIRONMENTAL MANAGEMENT INSTRUMENT**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, hereby consult on the intention to adopt the National Web Based Environmental Screening Tool in terms of regulation 4(1) and 7 of the Regulations Laying Down the Procedures to be Followed for the Adoption of Spatial Tools or Environmental Management Instruments, 2019.

The National Web Based Environmental Screening Tool is a spatially enabled tool which has been developed to, among others, identify areas of "very high", "high", "medium" and "low" environmental sensitivities on a particular site. Environmental sensitivity ratings are intended to be used to exclude activities identified in terms of section 24(2)(a) and (b) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) from the requirement to obtain environmental authorisation prior to commencement, as contemplated in terms of sections 24(2)(c) and (e) of the National Environmental Management Act, 1998 (Act No. 107 of 1998), when identified by the Minister in a Government Notice.
