### Definitions

1. In this notice "the Notice" means the notices published by Government Notice No. R. 544 of 2 August 2010, as amended by Government Notices Nos. R. 660 of 30 July 2010 and R. 1159 of 10 December 2010.

### Insertion of items 55A and 55B in the Notice

2. The following items are hereby inserted in the Notice, after item 55:

**"55A.** The construction of facilities for the treatment of effluent, wastewater or sewage with an annual throughput capacity of more than 2000 cubic metres but less than 15000 cubic metres.";

**"55B.** The expansion of facilities for the treatment of effluent, wastewater or sewage where the expanded capacity will be increased by 15000 cubic metres or more."
