**PROVISIONAL GENERAL PUBLISHED REASONS PERTAINING TO THE RECONSIDERATION OF
DECISIONS ON APPEAL IN THE HAKE LONGLINE SECTOR
FISHING RIGHT ALLOCATION PROCESS 2021/2022**

INTRODUCTION AND BACKGROUND

1. This document is the Provisional General Published Reasons pertaining to the reconsideration of decisions on appeal in the Hake Longline sector, issued by the Minister of Forestry, Fisheries and the Environment (the Minister).¹
2. The Department of Forestry, Fisheries and the Environment (the Department) allocated commercial fishing rights in nine (9) sectors during the 2021/2022 Fishing Rights Allocation Process (FRAP), including the Hake Longline sector.
3. Interested applicants were able to submit their applications from 1 November 2021 via the Department's online portal. The Department received four hundred and forty-six (446) applications in the Hake Longline sector.

DELEGATED AUTHORITY'S DECISION

4. In February 2022, the Delegated Authority finalised the allocation of commercial Hake Longline fishing rights.
5. The Delegated Authority determined different threshold scores for entities to achieve in order to qualify for the allocation of a commercial Hake Longline right. The thresholds determined by the Delegated Authority were as follows: 55% for Category A, 80% for Category B, and 70% for Category C.
6. Category A
The Delegated Authority received one hundred and five (105) applications from Category A applicants, and sixty seven (67) successful Category A applicants were awarded rights. Sixty eight (68) appeals were lodged by Category A applicants.
7. Category B
The Delegated Authority received one hundred and twenty nine (129) applications from Category B applicants and seven (7) successful Category B applicants were awarded rights. Eighty two (82) appeals were lodged by Category B applicants.

8. Category C

The Delegated Authority received two hundred and twelve (212) applications from Category C applicants and fifteen (15) Category C applicants were awarded rights. One hundred and thirty-two (132) appeals were lodged by Category C applicants.

APPEALS IN TERMS OF SECTION 80 OF THE MLRA

9. Applicants who were dissatisfied with the Delegated Authority's decision were entitled to appeal against the decision(s) of the Delegated Authority, in terms of section 80 of the Marine Living Resources Act 18 of 1998 (MLRA), read with regulation 5 of the Regulations to the MLRA, via the Department's FRAP online portal. The closing date for the submission of appeals was 29 July 2022.

10. The Department received two hundred and eighty (280) appeals in the Hake Longline sector across the different categories of applicants.

11. Minister Barbara Creecy, the erstwhile Minister of Forestry, Fisheries and the Environment, finalised the appeals in the Hake Longline sector on 4 November 2023.

12. The outcome of these appeals produced the following results:

12.1 Category A

Eight (8) entities scored higher than the 55 % threshold on appeal and were eligible to be allocated rights. One (1) entity successfully appealed its categorization as a Category B. Its application was reconsidered as a Category A applicant, and it scored above the 55% threshold. The total number of successful applicants in Category A increased from sixty-seven (67) to seventy-six (76).

12.2 Category B

Three (3) entities scored above the 80% threshold of 80%, after the recalculations of scores on appeal. Minister Creecy elected not to revoke any rights allocated by the Delegated Authority and instead to reduce the threshold for Category B applicants from 80% to 76.73%, this being the lowest ranking appeal score of the entity that was awarded a right by the Delegated Authority. On this approach, an additional two (2) Category B applicants score above the threshold on appeal. This will bring the total number of right holders in Category B from seven (7) to nine (9).

12.3 Category C

Similar to Category B, Minister Creecy elected not to revoke any rights allocated by the Delegated Authority, instead the threshold was reduced from 70% to 68,66%, this being the lowest ranking

appeal score of the entity that was awarded a right under the Delegated Authority. Six (6) additional applicants scored higher than this threshold on appeal, bringing the total number of rights holders in Category C from fifteen (15) to twenty-one (21).

JUDICIAL REVIEW APPLICATIONS

13. Following the finalisation of the appeals in terms of section 80 of the MLRA, eighteen (18) entities instituted judicial review applications in the Western Cape High Court.
14. The review applications were resolved by agreement between the parties. In terms of the agreed court orders:
 - 14.1 The Minister's appeal decisions were reviewed and set aside.
 - 14.2 The Minister was required to rescore, reconsider, and assess the appeals of the eighteen (18) entities.
 - 14.3 The applicants had to be informed in writing of any external information relied upon, and such information had to be provided to them.
 - 14.4 The applicants were given the opportunity to submit supplementary grounds of appeal.
 - 14.5 A notice of the intended decision had to be published before the Minister made a final decision.
 - 14.6 The rescoring, reconsideration, and assessment had to be finalised by 30 July 2025 to allow successful entities to commence fishing on 1 August 2025.
 - 14.7 The Total Allowable Catch could be adjusted depending on the outcome of the reconsideration of the appeals.

RECONSIDERATION OF APPEALS

15. In determining each of the appeals, I considered all relevant factors and the information before me, including but not limited to:
 - 15.1 The Marine Living Resources Act, 1998 (Act No 18 of 1998);
 - 15.2 The Regulations in terms of the Marine Living Resources Act;
 - 15.3 General Policy on the Allocation of Commercial Fishing Rights: 2021;
 - 15.4 The Policy for the Allocation and Management of Commercial Fishing Rights in the Commercial Hake Longline fishery: 2021;
 - 15.5 The FRAP applications;
 - 15.6 The Delegated Authority's GPR dated 28 February 2022;
 - 15.7 The Delegated Authority's decision letters;
 - 15.8 The Appeal forms;

- 15.9 Regulation 5 (3) reports;
 - 15.10 The review applications;
 - 15.11 The respective court orders; and
 - 15.12 Relevant case law.
16. The first appeal that was reconsidered was that of Ukuloba Kulungile Investments (Pty) Ltd. This appeal was finalised on 13 August 2024. The remaining seventeen (17) appeals was finalised in two phases.
17. The first phase involved the reconsideration of ten (10) appeals. The Appellants were:
- 17.1 Argento Trading 69 CC;
 - 17.2 Business Compliance Advisors (Pty) Ltd;
 - 17.3 Diablo Trade 113 (Pty) Ltd;
 - 17.4 Kupukani Fishing (Pty) Ltd;

 - 17.6 Mossel Bay Indigenous Fisherman CC;
 - 17.7 NPS Agencies CC;
 - 17.8 Pellsrus Historical Fishing Corporation CC;
 - 17.9 Prairie Pride Trading CC; and
 - 17.10 Umzamowethu (Oyster Bay) Fishermen's Corporation CC.
18. The second phase involved the reconsideration of appeals lodged by:
- 18.1 Domex 149 (Pty) Ltd;
 - 18.2 Ezabantu Fishing (Pty) Ltd;
 - 18.3 Hacky Fishing (Pty) Ltd;
 - 18.4 I Fortune & Crew (Pty) Ltd;
 - 18.5 Khulani Fishing (Pty) Ltd;
 - 18.6 Rainbow Nation Fishing (Pty) Ltd; and
 - 18.7 Siyabona Fishing (Pty) Ltd.
19. Each of the appeals were considered on its own merit and the appellants will be provided with a decision detailing the assessment and outcome of its individual appeal decision.
20. The appeals were assessed based on the balancing criteria and weighting outlined in the Delegated Authority's GPR. To ensure fairness, applicants within the three different categories were compared and assessed against the applicants in the same category.

21. The court orders, involving the entities that were part of phase two, provided the appellants with an opportunity to submit supplementary grounds of appeal. Several entities did so, and these submissions were duly considered as part of the individual appeal decisions.

RECONSIDERATION OF BALANCING CRITERIA

22. The review applications identified the scoring of certain questions as having been done inconsistently and not in line with the provisions of the Appeals GPR. These questions include: 5.3, 6.3, 6.6, 6.7, 6.10, 6.15, 6.26, 7.1, 7.2, 8.4, 8.6, 8.7, 8.8 and 9.1.
23. During the reconsideration of the appeals, the calculations for all applicants in the sector were revised. Since applicants within a category are compared to others in the same category, it was important to recalculate the results using the correct formula and to apply the scoring methodology consistently to ensure a like-for-like comparison among applicants in each category.
24. Questions 6.11, 6.17, 6.19, 6.21, 6.23 and 6.24 - The Delegated Authority scored applicants that answered YES to these questions a score of five (5); and applicants that answered "NO", "N/A" or left their response BLANK, were awarded a score of zero (0). Some appellants argued that they are not "Designated Employers" per the requirements of the Act, and they are therefore not required to comply with the legislation relevant to these questions. I am in agreement with the position adopted by Minister Creecy that the applicants who are not designated employers ought to be allocated the maximum of 5 points, where appropriate. In my view, this is a fair and reasonable approach. This will ensure that none of the applicants are disadvantaged by the scoring of these questions. I applied this approach consistently to all questions that related to legislative compliance, where relevant.

QUANTUM ALLOCATION METHODOLOGY (QAM) ON APPEAL

25. The QAM outlines the methodology used to allocate the Hake Longline Total Allowable Catch (TAC) to applicants who were successful in their applications or appeals. As a starting point, it must be recognised that the demand for commercial fishing rights in the Hake Longline sector far exceeds the quantum of the resource available for allocation on a sustainable basis.
26. The allocation of TAC is not an isolated exercise. It takes place within an existing socio-economic context, involving a variety of businesses of different sizes and operating models, which have established employment, investments, operations, and transformation credentials based on prior allocations of rights in the Hake Longline fishery.

27. The MLRA requires consideration of the introduction of new entrants when allocating long-term fishing rights. In order to accommodate new entrants, the TAC previously held by existing Hake Longline right holders must be reconsidered. This necessitates striking a balance between the legislative imperative of introducing new entrants and the need to maintain and protect the stability of the sector which include the employment opportunities created by existing right holders.
28. The decision on how to divide the limited available resource among various competing applicants is inherently complex, polycentric, and laden with policy considerations. Within this broader decision, there are necessarily a myriad of smaller but equally complex policy and balancing decisions, as well as judgement calls to be made.
29. Having considered all these factors, I am inclined to adopt the QAM that was implemented by the Delegated Authority, with only minor changes which are in keeping with the decisions made regarding correction of scores for the assessment phase. The calculations for each criteria are described in section 9.3 of the Delegated Authority's GPR, the only amendment was that the number of permanent and temporary employees in the sector (as opposed to total for that entity) were used for criteria 7.1 and 7.2.
30. The Delegated Authority considered the broad starting principles as stated in the Policy on the Allocation and Management of Commercial Fishing Rights in the Hake Longline Fishery: 2021 (HLL Policy: 2021) which was to attempt balancing broadening access to the fishery through the introduction of the new entrants against improving the allocation to the smaller Right Holders while attempting to minimize negative impact on the industry as a whole. Once again it should be noted that the formula to calculate the quantum ranking is separate from the assessment score which determines whether or not an application was successful.
31. The criteria for the quantum ranking used multiple weighted criteria as set out in the table below:

32. The quantum score achieved by each entity will be included as annexures.
33. I am satisfied that the factors used to determine the quantum score strike an appropriate balance between the different factors which I am required to consider when allocating the commercial Hake Longline TAC.

CONCLUSION

34. The provisional list of commercial fishing rights holders and its Total Allowable Catch in the Hake Longline sector are set out in:
- 34.1 Category A- **Annexure A and A1**;
 - 34.2 Category B- **Annexure B and B1**; and
 - 34.3 Category C- **Annexure C and C1**.
35. The court orders requires that a provisional decision be published and that interested parties be afforded the opportunity to make submissions by 30 June 2025 after which a final determination on the allocation of rights and quantum will be made.
