Mr Z R Xalisa (EFF) to ask the Minister of Environmental Affairs:

(1) With reference to her reply to question 1990 on 3 August 2017, wherein she stated that the 12 illegal dumping sites would be licensed in the current financial year, what are

the requirements for the legalisation of a dumping site;

(2) whether all 12 dumping sites have been licensed; if not, why not? NO4195E

291. THE MINISTER OF ENVIRONMENTAL AFFAIRS REPLIES:

1) Waste disposal facilities ('dumping sites' referred to in the questions) need to be licensed in terms of

the National Environmental Management: Waste Act (Act 59 of 2008). The process to follow when

applying for a Waste Management License is guided by the National Environmental Management Act

(Act 107 of 1998): Environmental Impact Assessment Regulations (GN 982, as amended), which

involves obtaining an environmental authorisation (EA), public consultation and other technical and

operational requirements.

The mandate to establish landfill disposal sites for the disposal of general waste rests with the

Municipalities. The municipalities apply to their respective provincial authorities for EIA's and waste

licences. The competent authorities for approval of applications are the Members of the Executive

Council responsible for the Entity in terms of Part B Schedule 5 of the Constitution (1996) of South

Africa. Due to funding constraints at the Municipal level, my Department has been assisting

Municipalties to carry out the EIA's in order to ensure that their facilities are licensed.

2) Since 2012, 341 unlicensed landfill sites have been succesfully licensed. New surveys are

conducted annually which result in new unlicensed landfill sites being indentified. The 12 unlicensed

waste disposal facilities were identified in the previous financial year (2016/17) through an annual

survey process that was conducted by Provincial Departments for licensing.

To date, service providers have been appointed to conduct Environmental Impact Assessments for the 12 unlicensed landfill sites. However, due to lengthy timeframes associated with the EIA processes and some sites requiring specialist studies, the licensing for the 12 unlicensed landfill sites will only be completed in the next financial year (2018/19). The Department is tracking and monitoring this process carefully.
