

# SCIENTIFIC OUTPUT OF THE BRANCH: FISHERIES MANAGEMENT OF THE DEPARTMENT OF AGRICULTURE, FORESTRY AND FISHERIES

2011

This document lists the scientific output of the Fisheries Management branch for 2011, arranged by output category. Given that the line function of the research component of the branch is to provide scientific advice for resource management, it follows that the bulk of the scientific output is in the form of working group documents, with the working groups being the forum for the formulation and dissemination of scientific advice. Hence 92 documents that contain scientific findings are included in this listing. The scientists have also disseminated their work to the broader scientific community, however, through 62 contributions at symposia and conferences. Twenty six of these were given at the 14th Southern African Marine Science Symposium in Grahamstown. The focus on line function research limits the potential for publication of novel research in the peer-reviewed literature, but nevertheless the branch's scientists published 14 papers of this type in 2011.
