1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

#### 2. **DEFINITIONS**

- (a) **"tender"** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "**price**" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

#### 1. PURPOSE

1.1 To appoint a service provider to compile the 2nd South Africa State of Waste Report for fourteen (14) months on behalf of the Department of Forestry, Fisheries and the Environment (DFFE).

#### 2. INTRODUCTION AND BACKGROUND

- 2.1 In 2018, the Department developed the first State of Waste Report (SoWR) for South Africa, following the 2011 National Waste Information Baseline Report (NWIBR) compiled under the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) ("NEMWA). The NEMWA is based on the waste management hierarchy, which is an internationally accepted model for waste management and guided the SoWR in reporting on quantities of waste generated, recycled, treated, disposed of and waste categories provided in Annexures 3 and 4 of the National Waste Information Regulations, 2012 in presenting quantities for the different waste streams. The first State of Waste Report gave the state of waste management in South Africa and assisted the government and the public in setting realistic and scientific-oriented estimates in the planning and decision-making processes.
- 2.2 Waste management is a complex and interrelated system that is neither easy to measure nor model, partly due to waste being a process output in some situations and a process input in others. Therefore, proper waste management requires a good understanding of the types and quantities of waste generated and how this waste is managed now and in the immediate future. To meaningfully assess the effectiveness of responses to the waste-related challenges that South Africa faces, monitoring the state of waste should take place at regular intervals, ideally every five years, to allow not only for the comparison of the state of waste between two discrete periods but also the identification of trends and reflection on the overall progress of responses.
- 2.3 Accurate information on waste generation, storage, treatments, reduction, recycling, recovery, and disposal is complex to source due to limited use of the South African Waste Information System (SAWIS) and lack of compliance with the National Waste Information Regulations, 2012. The first SoWR reported a general lack of data on waste generation and management in South Africa reported in municipal Integrated Waste Management Plans (IWMPs), and the SAWIS under-reporting for several general waste streams (e.g., commercial and industrial waste, organic waste, glass, and plastic). The challenges were attributed to a lack of weighbridges and capacity at several of the facilities, primarily municipal landfill sites. Furthermore, the data reported for municipal waste disposal could not differentiate plastic, organic waste, paper, and glass from the municipal waste stream.
- 2.4 While it is acknowledged that the DFFE has established a SAWIS under Section 60 of the Waste Act for the collection, recording, management, and analysis of waste, the existing information contained in the

system is limited due to poor waste data reporting. Moreover, the SoWR is essential in refining the information and knowledge base on which the policy agenda and decisions about waste are made to stimulate debate and raise awareness on the key issues and challenges related to waste generation and management in South Africa.

# 3. OBJECTIVES

- 3.1 The objective of this request for a proposal is:
  - 3.1.1 To appoint a service provider to review the first SoWR, gather the relevant waste data from various sources, and compile South Africa's 2nd State of Waste Report (SoWR) that must provide reliable and scientifically credible information about the condition and prospects of the environment that is impacted or affected by various waste management practices.
  - 3.1.2 Provide objective and accurate information about the historical trend and state of waste management in South Africa.
  - 3.1.3 Assess the relationship between human activities, responsibilities, and the effects of pollution on the environment.
  - 3.1.4 Acquire, accumulate, and analyse accurate periodic data of the waste management sector and present it in a synthesised manner.
  - 3.1.5 Assess progress toward implementing the waste policies and actions and responses by the government and the private sector to mitigate adverse environmental pollution effects.
  - 3.1.6 Provide generation and management trends to monitor the effectiveness of existing policies and waste management programmes.

#### 4 SCOPE AND EXTENT OF WORK

#### 4.1 Inception Phase

4.1.1 The Service Provider must attend an inception meeting and present the draft inception report that must be sent to DFFE at least three (03) working days before the meeting date.

#### 4.2 Implementation Phase

The role of the Service Provider is to carry out the following tasks on behalf of the DFFE:

- 4.2.1 Review and update the 2018 State of Waste Report (SoWR)
- 4.2.2 Identify and update indicators that will be used in the 2nd SoWR.
- 4.2.3 Identify emerging issues on various waste streams to inform future research or study.
- 4.2.4 Determine the Municipal waste composition and volumes by waste streams disposed of (refer to Annexure 3 of the National Waste Information Regulations,2012).

- 4.2.5 Conduct secondary research, including a literature review, and collect source material to enhance the report's global, regional, national, provincial, and local trends and discussion. This will include reviewing relevant global, regional, national, provincial, and metropolitan environmental and waste management reports. The process must also take cognisance of other planning documents such as National Development Plan, National Waste Management Strategy, Delivery Agreement on Government Outcomes, Sustainable Development Goals (including associated targets and indicators), STATSSA General Household Surveys and Census reports, Integrated Waste Management Plans (IWMP), Extended Producer Responsibility Regulations and the associated schemes, Industry Waste Management Plans (IndWMP), including the implementation of the Waste Research, Development and Innovation (RDI) Roadmap and all other related plans and strategies.
- 4.2.6 Report on the Waste Act implementation successes and challenges.
- 4.2.7 Compile the 2nd SoWR using the relevant and credible data and information gathered during the research and literature review. The report must include high-quality (300 dpi or more) diagrams, maps, graphs, Tables, Figures, and a proper references list. The Driver, Pressure, State, Impact, and Response (DPSIR) reporting framework or a hybrid must be applied during the writing process to ensure harmony and linkages in different sections of the report.
- 4.2.8 The SoWR must provide objective and accurate information on the generation, handling, storage, transportation, reuse, recycling, recovery, treatment, import, export, and the final disposal of waste and the impact of the various waste management options (Annexure 3 5 of the National Waste Information Regulations, 2012) on land, air, water, and human lives;
- 4.2.9 Identify problematic waste streams, and analyse appropriate management strategies to deal with such waste streams in consideration of the local context; consider and analyse progress with implementing Operation Phakisa delivery initiatives on waste management;
- 4.2.10 Report on the Waste Exclusion Regulations and the impact on the waste sector;
- 4.2.11 Consider and analyse the waste-related issues in the Sustainable Development Goals (SDGs) related to waste management.
- 4.2.12 The report must include the state of waste service provision and waste infrastructure (e.g., landfills, treatment facilities, Material Recovery Facilities (MRFs, Buy-Back Centre, storage facilities, etc.), and an indication of waste facilities' legal compliance.
- 4.2.13 Organise and present the draft reports to stakeholder engagement workshops, the Project Steering Committee (PSC), and key stakeholders. It is envisaged that, as a minimum, the following stakeholder engagement workshops will be conducted either physical, online, or hybrid:
  - a) One (01) online national SoWR Framework discussion workshop.
    - 5

- b) One hybrid workshop presenting the 1<sup>st</sup> draft SoWR (the DFFE will provide the venue);
- c) Two (02) virtual national consultation workshops presenting the 2<sup>nd</sup> draft and final SoWR.
- d) Ad-hoc meetings with the key stakeholders and the Department for data sourcing and discussions or analysis; and
- e) One (01) final online refinement workshop.
- 4.2.14 Identify peer reviews (outside the bidding organisation) and facilitate the process of peerreviewing the contents of the report. The project steering committee must consent to the identified peer reviewer.
- 4.2.15 Incorporate comments/ inputs received from the stakeholder consultation process, including from the peer-reviewing process.
- 4.2.16 Provide the copy-editing service mainly focusing on the report's readability, grammar, tone, layout, and pitch. The outcome must be an easy-to-read report comprehensible to a broad spectrum of potential readers interested in discovering more about the State of Waste in South Africa.
- 4.2.17 Source all necessary photographs, images, and artworks to enhance the design of the report.

# 4.3 Close-Out Phase

- 4.3.1 The Service Provider is expected to submit to the DFFE two (02) hard copies, a soft copy (Universal Serial Bus) of a Word version, and a print-ready PDF version of the report for sign-off. Upon sign-off of the report, all the data collected for the study (drawn graphs, high-resolution images, and maps (300 dpi or higher) used in the report must be submitted to the DFFE.
- 4.3.2 The service provider must submit a PowerPoint presentation summarising the project, deliverables, and report.
- 4.3.3 The service provider must provide a spreadsheet containing a list of Figures, Tables, and models, used in the report as well as source materials.

# 9.4 PHASE 3: PRICE AND PREFERENCE POINTS

- 9.4.1 The preference point system applicable for this bid is 80/20.
- 9.4.2 The following preference point system will be followed to advance the categories of persons:
  - a. For contracts with a Rand value up to R50 000 000, a maximum of 20 points may be allocated for specific goals as contemplated above, provided that the lowest acceptable tender scores 80 points for price.

i. The applicable formula to be used is Ps=80[1-(Pt-Pmin)/Pmin]. Provided:

Ps = Points scored for the price of the tender under consideration.

Pt = Price of tender under consideration; and

Pmin = Price of the lowest applicable tender.

- ii. total of 20 points may be awarded to a tenderer as follows:
  - 20 points: if the Bidder has more than 50% (fifty percent) by Black people, Women, or people with disabilities
  - 0 Points: for 50% and below ownership by stipulated categories of persons
- 9.4.3 The bid will be awarded to a bidder with the highest points on price and Preference Points on condition that they have met all phases of the evaluation criteria and complied with the tender requirements set out in the tender document. However, a contract may be awarded to a tenderer that did not score the highest points by section 2(1) of the PPPFA.
- 9.4.4 A maximum of 20 Points will be allocated for either of the specific goals.

- 9.4.5 For service providers to claim preference points the following must be adhered to:

**NB:** Failure on the part of a tenderer to submit proof or documentation stated above in terms of this tender to claim preference points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

#### 10 BID SUBMISSION REQUIREMENTS

- 10.1 Bidders must ensure that the following submission requirements, which will be needed for evaluation purposes are included in their bid proposal and are as follows:
  - 10.1.1 The service provider must draft a table of contents that will indicate where each document is in the proposal.
  - 10.1.2 The information in the CV of the proposed Project Leader must include relevant experience in the chosen area of expertise.

- 10.1.3 Project reference specifying the role played by the service provider in the listed projects or assignments.
- 10.1.4 A detailed project plan with a clear indication of who will be responsible for the management of the assignment as well as its execution. The allocation of team members on the assignments must be based on the experience in delivering the scope of work as listed
- 10.1.5 Standard bidding documents (SBD1, 3.3, 4, and 6.1).
- 10.1.6 Copy of Central Supplier Database (CSD) report or tax pin certificate from SARS.
- 10.1.7 Letter of Authority to sign documents on behalf of the company.

## 11 LEGISLATIVE FRAMEWORK OF THE BID

- 11.1 Tax Legislation
  - 11.1.1 Bidder must at all-time be compliant when submitting a proposal to DFFE and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).
  - 11.1.2 Bidders who make taxable supplies more than R1 million in any 12-month conservative period are liable for compulsory VAT registration, but a person may also choose to register voluntarily provided that the minimum threshold of R50 000 has been exceeded in the past 12-month period.
  - 11.1.3 Bidders who meet the above requirement must register as VAT vendors, if successful, within one month of award of the bid.
  - 11.1.4 SARS Tax Status Pin requirements / or Central Supplier Database (CSD) number or report must be provided.

#### 11.2 Procurement Legislation

- 11.2.1 Bidders must be cognisant of the legislation and/or standards specifically applicable to the services.
- 11.2.2 Bidders are requested to submit a valid B-BBEE Status Level Verification Certificate issued by SANAS Accredited Verification Agency, or B-BBEE Certificate issued by CIPC, or a Sworn Affidavit commissioned by Commissioner of Oaths together with their bids. The sworn affidavit must be signed by the deponent (Bidder), in the presence of a Commissioner of Oaths where the Commissioner of Oaths must affix his/her signature, together with the stamp of the office, and affix a date on which the signature was affixed. Furthermore, the dates of the deponent and the CoO must correspond.

- 11.2.3 If the application is made by a Joint Venture or Partnership, the accreditation credentials in the name of joined entities must be submitted. Members of the joint venture must meet the requirements of the proposal.
- 11.3 Privacy and Protection of Personal Information Act 4 of 2013
  - 11.3.1 Protecting personal information is important to the Department of Forestry, Fisheries, and the Environment. To do so, DFFE follows general principles by applicable privacy laws and the Protection of Personal Information Act 4 of 2013 (POPIA).
  - 11.3.2 DFFE's role as the responsible party is amongst others to process personal information for the intended purpose for which it was obtained and in line with legal agreements with its respective/ prospective service providers and third parties.
  - 11.3.3 DFFE will process personal information only with the knowledge and authorisation of the bidder/ respondent and will treat the personal information which comes to its knowledge as confidential and will not disclose it unless so required by law or subject to the exception contained in the POPIA.
  - 11.3.4 DFFE reserves all the rights afforded to it by the POPIA in the processing of any of its information as contained in this bid and the bidder/respondent is required to comply with all prescripts as detailed in the POPIA relating to all information concerning DFFE.
  - 11.3.5 In responding to this bid, DFFE acknowledges that it will obtain and have access to the personal information of the bidder/ respondent. DFFE agrees that it shall only process the information disclosed by the bidder/ respondent in their response to this bid for evaluation and subsequent award of the tender and by any applicable law.

# 12 SPECIAL CONDITIONS OF THE CONTRACT

- 12.1 On appointment, the performance measures for the delivery of the project will be closely monitored by the DFFE.
- 12.2 The service provider/s will submit a soft copy weekly progress report for the first months from the start of the project then submit monthly progress reports to the Programme Manager, within four (04) days after the end of each month and quarter for the duration of the project. Failure to submit the required reports on time will result in penalties.
- 12.3 The Programme Manager shall do the ongoing management of the Service Level Agreement.
- 12.4 Appointed service provider may be subjected to security vetting and screening.
- 12.5 The appointed Service Provider may be subjected to security vetting and screening.
- 12.6 The service provider/s must guarantee the presence of the senior in charge of fieldwork throughout the duration of the contract.

- 12.7 Prior to the appointment of a replacement, the Programme Manager must approve such appointment. If the senior has to leave the project, a period of at least one (1) month is required, in which the senior must work parallel with the next person (senior consultant with similar expertise and equal years of experience) appointed able to transfer skills and knowledge.
- 12.8 All the conditions specified in the **General Conditions of Contract (GCC)** will apply and where the conditions in the special conditions of contract contradict the conditions in the general conditions of contract the special conditions of contract will prevail.
- 12.9 The service provider shall notify the DFFE in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the service provider from any liability or obligation under the contract.
- 12.10 The service provider will submit monthly progress reports as per the agreed to work plan, to the Programme Manager, within 3 days after the set date.
- 12.11 The proposals should be submitted with all required information containing technical information.
- 12.12 A trust, consortium, or joint venture will qualify for Preference Points if their average combined ownership is more than 50% (fifty percent) of ownership on specific goals (e.g. two or more companies claiming preference points, Ownership/ Directorship will be combined and divided by the number of companies to ascertain the preference points),
- 12.13 DFFE reserves the right to request additional information to validate any information submitted by bidders including preference points claimed

### NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

### **General Conditions of Contract**

1. Definitions	1.	The following terms shall be interpreted as indicated:
	1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
	1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
	1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
	1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
	1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
	1.6	"Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
	1.7	"Day" means calendar day.
	1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
	1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
	1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will bemanufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

	obligations of the supplier covered under the contract.
	1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
2. Application	2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excludingimmovable property, unless otherwise indicated in the biddingdocuments.
	2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
	2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
3. General	3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
	3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from <u>www.treasury.gov.za</u>
4. Standards	4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
5. Use of contract documents and information; inspection.	5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
	5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
	5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
	5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
6. Patent rights	6.1 The supplier shall indemnify the purchaser against all third-partyclaims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security	7.1	Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
	7.2	The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
	7.3	The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
		<ul> <li>(a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or</li> <li>(b) a cashier's or certified cheque</li> </ul>
	7.4	The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.
8. Inspections,	8.1	All pre-bidding testing will be for the account of the bidder.
tests and analyses	8.2	If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
	8.3	If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
	8.4	If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
	8.5	Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
	8.6	Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
	8.7	Any contract supplies may on or after delivery be inspected, tested or

analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.
- 9. Packing
  9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
  - 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.
- 10. Delivery10.1Delivery of the goods shall be made by the supplier in accordance with<br/>the terms specified in the contract. The details of shipping and/or other<br/>documents to be furnished by the supplier are specified in SCC.
  - 10.2 Documents to be submitted by the supplier are specified in SCC.
- **11. Insurance** 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
- **12. Transportation** 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

# 13. Incidental13.1The supplier may be required to provide any or all of the following<br/>services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;

- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
- 14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
  - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
  - (b) in the event of termination of production of the spare parts:
    (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
    - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that theyincorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising fromdesign, materials, or workmanship (except when the design and/ormaterial is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of finaldestination.
  - 15.2 This warranty shall remain valid for twelve (12) months after thegoods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
  - 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
  - 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
  - 15.5 If the supplier, having been notified, fails to remedy the defect(s)within the period specified in SCC, the purchaser may proceed to take

		such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
