#### 1. PURPOSE

- 1.1 To appoint a service provider to consolidate ('tie loose ends') issues that emanate from stakeholder engagements, including subsector Working Groups (WG) and Small Working Teams, and inputs from various other stakeholder engagement sessions undertaken after 31<sup>st</sup> March 2022 to date, and finalise a stakeholder report.
- 1.2 To explicitly incorporate into the overarching Ocean Economy Master Plan document the initiatives that were included in the subsector implementation plans but not in the main document. These subsectors are Marine Manufacturing and Repairs, Marine Transport (including Freight & Logistics), Offshore Oil & Gas, Fisheries (Commercial & Small scale), as well as Aquaculture (Marine & Freshwater).
- 1.3 To make suggestions on how the existing coordination structures, especially the Delivery Units, could be optimally allocated to departments for coordination.

## 2. INTRODUCTION AND BACKGROUND

- 2.1 Cabinet, early in 2013, instructed the Minister for Water and Environmental Affairs to coordinate discussions between all relevant departments, public entities, and stakeholders to examine the economic potential of the ocean economy sub-sectors of Marine Transport & Manufacturing, Offshore Oil and Gas Exploration, and Aquaculture for South Africa to contribute to job creation and growth (DEA, 2014, p.2). That process started with the Phakisa Labs from 8 July to 15 August 2014 and produced detailed initiatives with clear actions that could, if implemented well, produce big and complex outcomes to move development towards government objectives of reducing unemployment, poverty, and inequality
- 2.2 The South African government had adopted the Malaysian Big Fast Results model of implementation to experiment for a period of 5 to 10 years, and, if successful, they would roll it out across all subsectors of the ocean economy. Thus, 15 August 2024 would be the tenth (10th) year of Operation Phakisa: Ocean Economy.
- 2.3 Incidentally, the Department of Planning, Monitoring and Evaluation (DPME), in September 2022, released a report on the implementation evaluation of Operation Phakisa programme ('Final Report on the Implementation Evaluation of the Operation Phakisa. DPME,2022'). Amongst this report's key findings are:
  - 2.3.1. The report's unequivocal support for the Operation Phakisa: Ocean Economy initiatives, including their action plans, as still viable proposals to achieve key outputs and outcomes

necessary to help South Africa solve the problems of unemployment and create growth in the identified sub-sectors of the ocean economy. The report in this regard encourages consideration of the still-relevant initiatives of Phakisa in the future development planning initiatives of the government, such as the current Ocean Economy Master Plan development process.

- 2.3.2. The failure of the 'business unusual' implementation method that relies on top government authorities' support, then the 'traditional' or usual government implementation arrangements of the MTSF, APPs, and MTEF, for it to be implemented. The report, therefore, proposes, with caution against what it calls 'malicious compliance,' the moving of the Phakisa Ocean Economy's implementation structures, targets, and initiatives into planning arrangements (MTSF, APPs, MTEF) of appropriate departments. Malicious compliance is explained as the inclusion of issues with no demonstrable link to advancing strategic objectives of government into the planning arrangements of government such as the Medium-Term Strategic Framework (MTSF), Annual Performance Plans (APPs), Medium Term Expenditure Frameworks (MTEF) and others.
- 2.4 As part of its Re-Invigorated Industrial Strategy (RIS), South Africa is engaged in a drive for sector-focused Master Plans in priority economic sectors. The Department of Forestry, Fisheries, and Environment (DFFE) was tasked to lead the development of the Ocean Economy Master Plan (OEMP) and its related Implementation Plans. The five (5) sub-sectors for which the Ocean Economy Master Plan is being developed are Marine Manufacturing and Repairs, Marine Transport (including Freight, Logistics, and Cargo), Aquaculture (Freshwater and Marine), Fisheries (Commercial and Small-scale), and Offshore Oil and Gas. OEMP (Version 4.1) was completed on 31 March 2022, and the development of the implementation plans, as well as other stakeholder interactions, are continuing. The officials of DFFE are experiencing several challenges, particularly around securing information to provide the basis for some identified priorities, as well as with the workload of extricating key issues as inputs for OEMP from volumes of recordings and reports made in the interactions with stakeholders.

#### 3. OBJECTIVES

The potential service provider will be expected to perform the following duties:

3.1 Consolidate inputs made from stakeholder interactions that were not consolidated into the Draft Ocean Economy Master Plan (OEMP) of 31 March 2022, as well as establish synergy between the OEMP and related draft implementation plans.

- 3.2 Consolidate ('tie loose ends') issues that emanate from stakeholder engagements, including subsector Working Groups (WG) and Small Working Teams, and inputs from various other stakeholder engagement sessions undertaken after 31<sup>st</sup> March 2022 to date, and finalise a stakeholder report.
- 3.3 To explicitly incorporate into the overarching Ocean Economy Master Plan document the initiatives that were included in the subsector implementation plans but not in the main document. These subsectors are Marine Manufacturing and Repairs, Marine Transport (including Freight & Logistics), offshore Oil & Gas, Fisheries (Commercial Small scale), as well as Aquaculture (Marine & Freshwater)
- 3.4 To make suggestions on how the existing coordination structures, especially the Delivery Units, could be allocated to departments for coordination.
- 3.5 Ensure explicit consolidation of the still-relevant Operation Phakisa: Ocean Economy initiatives into the OEMP and related implementation draft plans.
- 3.6 Make proposals on how the implementation of OEMP priorities that incorporate relevant and viable Operation Phakisa: Ocean Economy initiatives, could be made part of the current government planning arrangements (MTSF, APPs, and MTEF), including pointing specifically which departments or state entities could be responsible for identified priorities and coordinating structures.

#### 4. SCOPE AND EXTENT OF WORK

- 4.1 The service provider will undertake an analysis of the inputs provided, existing reports, the draft Ocean Economy Master Plan (OEMP version 4.1), and the draft subsector implementation plans.
- 4.2 Provide recommendations on the allocations of existing and new coordination structures including Delivery Units to the departments.
- 4.3 The service provider shall *extract key issues* from the inputs made in the stakeholder interactions that were conducted by the officials of the Department of Forestry, Fisheries, and Environment (DFFE) that were not considered in the development of the Ocean Economy Master Plan (version 4.1). as well incorporates emerging aspects that were not considered in the draft Master Plan for inclusion into the final draft documents such as elements of the Marine Transport Value Chain. Emphasis is made that documents produced will constitute a final version for discussions with the DTIC-prescribed master plan co-creation structures in the form of Industry Reference Group (IRG) and Executive Oversight Committee (EOC). Before submission to the Cabinet.
- 4.4 To accelerate the finalisation of the Master Plan development process, the service provider shall or can opt to sub-contract secretarial service to:
  - 4.4.1. Transcribe recordings of stakeholder interactions to pick up critical issues raised,

- 4.4.2. Interact with convenors of Working Groups and Small Working Teams, as far as they need assistance clarity, and finality to issues raised in recordings.
- 4.4.3. The <u>extent of the recordings to be dealt with</u> will be provided at a briefing session to be announced.
- 4.5 The potential service provider shall in their proposals indicate:
  - 4.5.1. The approaches they will be adopting to undertake the tasks, especially the justification of why the proposals made will succeed,
  - 4.5.2. Consideration of the Final Report on the Implementation Evaluation of Operation Phakisa (DPME,2022) and Ocean Economy Master Plan (OEMP) (version 4.1) is critical. Potential service providers will receive these on the briefing sessions whose dates will be announced.
  - 4.5.3. Costs to the components of the project, considering the objective of the project and deliverables stated.
  - 4.5.4. Provide information to give insights to their level of experience in the undertaking of the nature of the task asked for herein.
- 4.6 The tasks shall be undertaken for a period of six (6) months from the date a service provider received an order number to undertake the task from DFFE, and every potential provider is expected to provide a project plan on how they will undertake the task within this timeframe.
- 4.7 A service provider shall be expected to provide a report that will, at the least, include:
  - 4.7.1. Demonstrate how the issues distilled from the stakeholder consultations have been included in the consolidated priorities of OEMP and related implementation plans.
  - 4.7.2. A final draft of the Oceans Economy Master Plan and consolidated implementation plan for the five subsectors
  - 4.7.3. Any other aspect covered under the Scope of Work and Expected Deliverables is listed below.

## 5. EXPECTED DELIVERABLES / OUTCOMES

- 5.1 The final draft of the Oceans Economy Master Plan
- 5.2 The final draft of a consolidated implementation plan for the five (05) subsectors
- 5.3 Submit a presentation deck that talks about major elements of the Master Plan and subsector implementation plans.
- 5.4 Provide stakeholder input consultation report that details the issues raised and the considerations thereof.

## 6. PERIOD / DURATION OF PROJECT / ASSIGNMENT

6.1. The duration of the project will be for a period of six (06) months after the issuing of an Official Order by DFFE to the successful provider.

## 7. COSTING / COMPREHENSIVE BUDGET

- 7.1 A comprehensive fixed costing must be provided on SBD 3.3 and Price Schedule Annexure A inclusive of all disbursement costs, such as delivery costs, traveling and accommodation costs, and other expenses inclusive of VAT. Include hourly rates for normal hours, after-hours, weekends, and public holidays as well as call-out fees and rates for kilometres travelled.
- 7.2 DFFE reserves the right to negotiate prices with recommended service providers identified in the evaluation process without offering the same opportunity to any other bidder(s) who have not been recommended.
- 7.3 A comprehensive offer must be provided in the same envelope as the technical proposal inclusive of all disbursement costs, expenses, and VAT (Annexure A Price Schedule /guidance: Service provider must quote for all activities as included in the Pricing Schedule unless indicated otherwise).
- 7.4 The quantities or hours provided are for evaluation only as the award and contract for this assignment will be based on rates only. Therefore, the bidder must state the rates and prices in rands.
- 7.5 The price will be valid for 120 days. The bid validity might be extended, and the new extension date shall remain valid until the award process is concluded. The bidders will be given seven (7) days from the date of the letter to respond, failure to do so will be deemed that the bidding company is in agreement with the content of the validity extension.

**NOTE:** Where applicable modification (Increase/ Decrease) of the given total capped hours on the pricing schedule is **strictly prohibited**. However, bidders are allowed to be innovative in allocating the hours across the line items or activities with the total capped hours remaining the same as provided by DFFE. Bidders who fail to comply with the requirements will be considered non-responsive and not further evaluated.

## 9.4. PHASE 3: PRICE AND PREFERENCE POINTS

- 9.4.1. The following preference point system will be followed to advance the categories of persons:
  - a) For contracts with a Rand value below R50 000 000, a total of 20 points may be allocated for specific goals as contemplated above, provided that the lowest acceptable tender scores 80 points for price.
    - i. The applicable formula to be used is Ps=80[1-(Pt-Pmin)/Pmin]. Provided:
      - Ps = Points scored for the price of the tender under consideration.
      - Pt = Price of tender under consideration; and
      - Pmin = Price of the lowest applicable tender.
    - ii. A total of 20 points may be awarded to a tenderer as follows:
      - 20 points: if the Bidder has more than 50% (fifty percent) Black people, Women, or people with disabilities
      - 0 Points: for 50% and below ownership by stipulated categories of persons
  - b) If it is unclear whether the 80/20 or 90/10 preference point system applies, either the 80/20 or 90/10 preference point system will be applied. In such a case, the lowest acceptable tender will be used to determine the applicable preference point system.
- 9.4.2. The bid will be awarded to a bidder with the highest points on price and Preference Points on condition that they have met all phases of the evaluation criteria and complied with the tender requirements set out in the tender document. However, a contract may be awarded to a tenderer who did not score the highest points only by section 2(1)(f) of the PPPFA.
- 9.4.3. The DFFE reserves the right to negotiate prices that are not deemed market-related and not to award the tender to the bidder with the lowest price.
- 9.4.4. The preference point system applicable for this bid is **80/20**.
- 9.4.5. A total of **20** points will be allocated for either of the specific goals:

SPECIFIC GOALS	80/20
>50% ownership by Black people, Or	20
>50% ownership by Women, Or	20
>50% ownership by people with Disability	20

9.4.6. For bidders to claim preference points, the following must be adhered to:

- a) Submit a complete and signed SBD 6.1,
- b) Submit a valid B-BBEE Status Level Verification Certificate issued by SANAS, or Accredited Verification Agency, or B-BBEE Certificate issued by CIPC, or a Sworn Affidavit commissioned by the Commissioner of Oaths together with their bids; or
- c) Submit a CSD report.

**NB:** Failure on the part of a tenderer to submit proof or documentation stated above in terms of this tender to claim preference points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

## 10. BID SUBMISSION REQUIREMENTS

- 10.1. Bidders should ensure that the following submission requirements, which will be needed for evaluation purposes are included in their bid proposal and are as follows:
  - 10.1.1 The service provider must draft a table of contents that will indicate where each document is in the proposal.
  - 10.1.2 The proposal shall consist of one master original document and must indicate the prices on SBD 3.3 and Annexure A for a detailed price schedule.
  - 10.1.3 The information in the CV of the proposed Project Manager should include relevant experience in the chosen area of expertise.
  - 10.1.4 Project reference specifies the role played by the service provider in the listed projects or assignments, the project value, and the duration of the project (start and end date).
  - 10.1.5 A detailed project plan with a clear indication of who will be responsible for the management of the assignment as well as its execution. The allocation of team members on the assignments should be based on the experience in delivering the scope of work as listed.
  - 10.1.6 Standard bidding documents (SBD1, 3.3, 4,6.1), completed and signed.
  - 10.1.7 Copy of Central Supplier Database (CSD) report and tax pin certificate from SARS.

#### 11. LEGISLATIVE FRAMEWORK OF THE BID

#### 11.1 Tax Legislation

- 11.1.1. Bidder must at all times attempt to be compliant when submitting a proposal to DFFE and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).
- 11.1.2. Bidders who make taxable supplies more than R1 million in any 12-month conservative period are liable for compulsory VAT registration, but a person may also choose to register voluntarily provided that the minimum threshold of R50 000 has been exceeded in the past 12-month period.
- 11.1.3. Bidders who meet the above requirement must register as VAT vendors, if successful, within one month of the award of the bid.
- 11.1.4. SARS Tax Status Pin requirements/ or Central Supplier Database (CSD) number or report must be provided.
- 11.2. Procurement Legislation
  - 11.2.1. Bidders should be cognisant of the legislation and/or standards specifically applicable to the services.
  - 11.2.2. If the application is made by a Joint Venture or Partnership, the accreditation credentials in the name of joined entities should be submitted. Members of the joint venture must meet the requirements of the proposal.
  - 11.2.3. Bidders are requested to submit a valid B-BBEE Status Level Verification Certificate issued by SANAS Accredited Verification Agency, or B-BBEE Certificate issued by CIPC, or a Sworn Affidavit commissioned by Commissioner of Oaths together with their bids. The sworn affidavit must be signed by the deponent (Bidder), in the presence of a Commissioner of Oaths where the Commissioner of Oaths must affix his/her signature, together with the stamp of the office, and affix a date on which the signature was affixed. Furthermore, the dates of the deponent and the CoO must correspond.
- 11.3 Privacy and Protection of Personal Information Act 4 of 2013
  - 11.3.1. Protecting personal information is important to the Department of Forestry, Fisheries, and the Environment. To do so, DFFE follows general principles by applicable privacy laws and the Protection of Personal Information Act 4 of 2013 (POPIA).

- 11.3.2. DFFE's role as the responsible party is amongst others to process personal information for the intended purpose for which it was obtained and in line with legal agreements with its respective/ prospective service providers and third parties.
- 11.3.3. DFFE will process personal information only with the knowledge and authorisation of the bidder/ respondent and will treat the personal information which comes to its knowledge as confidential and will not disclose it unless so required by law or subject to the exception contained in the POPIA.
- 11.3.4. DFFE reserves all the rights afforded to it by the POPIA in the processing of any of its information as contained in this bid and the bidder/respondent is required to comply with all prescripts as detailed in the POPIA relating to all information concerning DFFE.
- 11.3.5. In responding to this bid, DFFE acknowledges that it will obtain and have access to the personal information of the bidder/ respondent. DFFE agrees that it shall only process the information disclosed by the bidder/ respondent in their response to this bid for evaluation and subsequent award of the tender and by any applicable law.

#### 12. SPECIAL CONDITIONS OF THE CONTRACT

- 12.1. .The service provider/s must guarantee the availability of the Project Leader for the duration of the contract as may be detailed in the agreed Project Plan.
- 12.2. The DFFE reserves the right to conduct regular site inspections for the duration of the contract period.
- 12.3. On appointment, the performance measures for the delivery of the agreed services will be closely monitored by the Project Manager.
- 12.4. The service provider will submit monthly progressive reports to the Project Manager, within three (03) days after the end of the month for the duration of the project, submitted in both soft and hard copies. The report must indicate all the equipment that was submitted to the service provider by DFFE, progress in terms of repairs and service, and invoicing per equipment. The total for all the invoices for the month together with the unpaid and paid invoices. Failure to submit the required reports on time may result in penalties.
- 12.5. The Programme Manager shall do the ongoing management of the Service Level Agreement.
- 12.6. The appointed service provider will be subjected to security vetting and screening
- 12.7. The service provider/s must guarantee the presence of the senior in charge of fieldwork throughout the contract.
- 12.8. Before the appointment of a replacement, the Programme Manager must approve such appointment. If the senior has to leave the project, a period of at least one (1) month is required, in which the senior

must work parallel with the next person (senior consultant with similar expertise and equal years of experience) appointed able to transfer skills and knowledge.

- 12.9. All the conditions specified in the General Conditions of Contract (GCC) will apply and where the conditions in the special conditions of contract contradict the conditions in the general conditions of contract the special conditions of contract will prevail.
- 12.10. The service provider shall notify the Department in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the service provider from any liability or obligation under the contract.
- 12.11. A Letter of Authority to sign documents on behalf of the company.
- 12.12. The service provider will submit monthly progress reports as per the agreed to work plan, to the Programme Manager, within 3 days after the set date.
- 12.13. The proposals should be submitted with all required information containing technical information.
- 12.14. For service providers to claim preference points the following must be adhered to:
  - 12.14.1.Submit a completed and signed SBD 6.1,
  - 12.14.2.Submit a valid B-BBEE Status Level Verification Certificate issued by SANAS, or Accredited Verification Agency, or B-BBEE Certificate issued by CIPC, or a Sworn Affidavit commissioned by the Commissioner of Oaths together with their bids; or
  - 12.14.3. Submit a CSD report
  - NB: Failure on the part of a tenderer to submit proof or documentation stated above in terms of this tender to claim preference points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 12.15. If the DFFE is of the view that a Bidder submitted false information regarding a Specific Goal, the DFFE must inform the Bidder accordingly and allow the Bidder to make representations within fourteen (14) days as to why:-
  - 12.15.1.the Tender may not be disqualified, or,
  - 12.15.2.if the Tender has already been awarded to the Bidder, the contract or order should not be terminated in whole or in part.
- 12.16. After considering the representations, the DFFE may, if it concludes that the information relating to a Specific Goal is false, disqualify the Bidder or terminate the Contract in whole or in part and if applicable, claim damages from the Bidder.
- 12.17. The Department shall consider Company and Individual(s) (Personnel) experience and Qualifications obtained within and outside the Republic of South Africa (RSA). The qualification obtained outside RSA shall for evaluation be accompanied by the SAQA Certificate of Evaluation (SCoE). The SCoE will indicate the recognition decision taken by SAQA concerning the foreign qualification and the

comparability of that qualification with a South African qualification registered on the National Qualification Framework (NQF). Foreign qualifications that are not accompanied by the SCoE shall not be considered for evaluation in this contract.

- 12.18. The proposals should be submitted with all required information containing technical information
- 12.19. Poor or non-performance by the bidder will result in the cancellation of contracts/orders.
- 12.20. Please take note that DFFE is not bound to select any of the firms submitting proposals. DFFE reserves the right not to award any of the bids and not to award the contract to the lowest bidding price.
- 12.21. DFFE will not be held responsible for any costs incurred by the service providers in the preparation, presentation, and submission of the proposal

#### 13. PAYMENT TERMS

13.1. DFFE undertakes to pay out in full or as per deliverables within thirty (30) days all valid claims for work done to its satisfaction upon presentation of an approved detailed claim and the required reports stipulated in special conditions. No payment will be made where there is outstanding information/ work not submitted by the Service Provider/s until that outstanding information is submitted.

## NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

### **General Conditions of Contract**

1. Definitions	1.	The following terms shall be interpreted as indicated:
	1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
	1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
	1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
	1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
	1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
	1.6	"Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
	1.7	"Day" means calendar day.
	1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
	1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
	1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

obligations of the supplier covered under the contract. 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing. These general conditions are applicable to all bids, contracts and orders 2. Application 2.1 including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents. 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works. 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply. 3. General 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged. 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za 4. Standards 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications. 5. Use of 5.1 The supplier shall not, without the purchaser's prior written consent, contract disclose the contract, or any provision thereof, or any specification, documents plan, drawing, pattern, sample, or information furnished by or on and behalf of the purchaser in connection therewith, to any person other information: than a person employed by the supplier in the performance of the inspection. contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance. 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract. 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser. 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser. 6. 		(a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or		
		(b) a cashier's or certified cheque		
	7.4	The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.		
8. Inspections,	8.1	All pre-bidding testing will be for the account of the bidder.		
tests and analyses	8.2	If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.

	8.5	Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.		
	8.6	Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.		
	8.7	Any contract supplies may on or after delivery be inspected, tested or		

analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.
- **9. Packing 9.1** The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract.
