

PURPOSE

The Department of Forestry, Fisheries and the Environment ("DFFE") / MLRF requires the Service Provider to undertake maintenance dredging that will result in the opening of the channel at the harbour mouth of the Gordon's Bay Proclaimed Fishing Harbour.

2. SPECIFICATIONS

The required dredging of the Gordon's Bay harbour basin and entrance channel will have to result in approximately 10 000 m³ of sand being removed for the basin and entrance to be operational. The dredging of the sediment should result in the channel being approximately 8m wide and deep enough to provide a depth of -3.5m MSL.A multi-beam out-survey will have to be carried out to show that the harbour has been dredged to the desired level.

Detailed description:

A Service Provider is required undertake maintenance dredging that will result in the opening of the channel at the harbour mouth of the Gordon's Bay Proclaimed fishing Harbour. The channel is blocked due to sand deposits that has accumulated because of sediment movement. Sand has built up in the harbour entrance to such an extent that larger vessels cannot use the harbour and smaller vessels can only enter and leave the harbour during high tide. Dredging is needed to restore the required water depths in the entrance channel and harbour basin. The channel should be dredged to a level that will accommodate the safe launching of vessels in the harbour. The Department is responsible for safe navigation and therefore an improvement in water depth due to dredging will contribute to the save navigation of vessels.

The location for the deposition of dredged material is the Bikini Beach or a location that will be agreed upon by the Department and the Service Provider. Bikini Beach (Figure 1) situated adjacent (to the west) of the main breakwater is a popular recreational area for both locals and international tourists. The beach has been subject to significant erosion and sediment transportation over the past decade. The removed sand will be used for beach replenishment in line with the existing maintenance management plan.

The dredging is to take place during an appropriate tide, with the dredged sediment deposited on bikini beach, within a cordoned-off area. The removal of sediment and opening of channel will have to be preferably undertaken during an appropriate tide at a time agreed upon by the Department and the Service Provider. The exact location for the deposition of sediment and distribution methods within the bikini beach will be agreed upon prior to the commencement of the activities.

The required dredging of the Gordons Bay harbour basin and entrance channel will have to result in approximately 10 000 m3 of sand being removed for the basin and entrance to be operational.

The dredging of the sediment should result in the channel being approximately 8m wide and deep enough to provide a depth of -3.5m MSL.A multi-beam out-survey will have to be carried out to show that the harbour has been dredged to the desired level.

A dredging plan developed by the appointed service provider will have to be submitted to the Department for approval prior to the commencement of dredging activities. The dredging plan must include but is not limited to the following aspects:

Method:

The dredged material should preferably be removed up from the seabed and be transported to the Bikini Beach. An indicative dredging operation is illustrated in Figure 1. The dredging should most likely be carried out with relevant machinery and equipment that include but is not limited to the following:

- A cutter-suction dredger or a dredging pump
- A relevant dredging equipment that can be accommodated in the Gordon's Bay Harbour
- Dredged material disposal plan
- An estimation of the volume quantity to be removed per hour or per day
- Hours of operation
- Sediment replenishment method

Pollution management

- Compliance to local air emissions and water quality standards
- Oil spill management

Safety

- Safety and access plan during dredging activities. The discharge area must be cordoned off to prevent the public from entering this area during discharging activities.
- Safety plan
- Access and use of site plan

Machinery

- Plant and equipment deployed on site must be in satisfactory operating condition and capable of safely and efficiently performing the work.
- List of machinery to be used

3. EVALUATION METHOD

3.1. PHASE 1: Mandatory requirements

- 3.1.1. The following table must be completed by the bidder by answering YES OR NO and attach proof.
- 3.1.2. Only bidders who achieve a "Yes" for all mandatory requirements and required proof has been submitted will proceed for evaluation to phase 3.

3.2. PHASE 2: Preferential Points (80/20 system)

- 3.2.1. An evaluation of Price and Specific Goals Preference points on the suppliers, that successful qualified to this stage of evaluation.
- 3.2.2. Calculation of points for price The Preferential Procurement Policy Framework Act (PPPFA) prescribes that the lowest acceptable bid will score 80 points (for tenders under R50m) or 90 points (for tenders above R50m) for price. Suppliers that quoted higher prices will score lower points for price on a pro-rata basis. Where functionality is set as criteria, only bid proposals that meets functionality requirements will be considered for evaluation on price and specific goals preference points.
- 3.2.3. The 80/20 as an appropriate preference point system will be used in the evaluation and adjudication of this quote. However, it must be extended that the lowest acceptable quote will be used to determine the applicable preference point system as per regulation (Section 3(2)(b) of the Preferential Procurement Regulations (PPR) 2022, which states: "If it is unclear which preference point system will be applicable, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable proposal will be used to determine the applicable preference point system". Therefore, either 80 or 90 points, depending on the rand value of the proposal, will be awarded to the suppliers who offers the lowest price, and proportionately fewer points are awarded

to those with higher prices. Either 20 or 10 points are then available as preference points for Specific Goals, as applicable. The contract will be awarded to the suppliers that scores the highest total number of adjudication points per <u>category</u>.

Calculating of points for Specific Goals

- 3.2.4. Points will be awarded to a supplier for specific goals. Bidders are required to submit the original and valid proof for preference points claimed or certified copies thereof; to substantiate their preference points claims. SBD 6.1 must also be duly completed, signed, and submitted alongside the bid to claim preference points. Failure to do so will result in Specific Goals preference points being forfeited.
- 3.2.5. The 80/20 as an appropriate preference point system will be used in the evaluation and adjudication of this quotation. However, it must be extended that the lowest acceptable supplier will be used to determine the applicable preference point system as per regulation (Section 3(2)(b) of the Preferential Procurement Regulations (PPR) 2022, which states: "If it is unclear which preference point system will be applicable, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable supplier will be used to determine the applicable preference point system". - 3.2.7. The SCM unit of the DFFE / MLRF will allocate preferential points (Specific Goals) to each company for its contribution towards empowerment of the black designated groups as prescribed in the Preferential Procurement Regulations of 2022, women, people with disabilities, youth as well as local economic development.
- 3.2.8. A supplier will not be disqualified from the quotation process if the suppliers does not submit supporting documents substantiating the specific goals preference points claimed or is a non-compliant contributor. Such some suppliers will score 0 for Specific Goals.
- 3.2.9. Suppliers will be subject to SCM conditions of the Department MLRF and the Preferential Procurement Regulations, 2022 issued in terms of section 5 of the Preferential Procurement Policy Framework Act (Act No 5 of 2000) (PPPFA).
- 3.2.10. The PPPFA prescribes that the lowest acceptable bid will score 80 or 90 points for price (as explained above, depending on whether the bid prices is more or less than R50million). Suppliers that quoted higher prices will score lower points for price on a pro-rata basis. Where functionality is set as a criterion, only bid proposals that meets functionality requirements will be considered to be evaluated on price and Specific Goals.
- 3.2.11. The contract will be awarded to the supplier scoring the highest points subject to section 2(1) (f) of the PPPFA, 2000.

4. SUBMISSION REQUIREMENTS

- 4.1 Suppliers should ensure that the following submission requirements, which will be needed for evaluation purposes are included in their bid proposal and are as follows:
 - 4.1.1 The SP must draft a table of content which will indicate where each document is located in the proposal.
 - 4.1.2 The proposal shall consist of two parts, namely the technical bid and the pricing bid (master and copies).
 - 4.1.3 Add documents that are required to be submitted with the bids. These documents include those included in phase one (1) and two (2) of evaluation criteria.
 - 4.1.4 Standard bidding documents (SBD1, 2, 3.1/3.3, 4, 6.1) completed and signed.
 - A valid copy of the Tax Clearance Certificate/ Tax Compliance Status Pin issued by SARS to the supplier/copy of Central Supplier Database (CSD)/ MA supplier Number must be submitted together with the bid.
 - In case of bids where Consortia / Joint Ventures / Sub-contractors are involved; such

5. SPECIAL CONDITIONS OF CONTRACT

- 5.1 On appointment, the performance measures for the delivery of the agreed services will be closely monitored by Department / MLRF.
- 5.2 The Department / MLRF will not be held responsible for any costs incurred by the SPs in the preparation, presentation and submission of the proposal.
- 5.3 All the conditions specified in the General Conditions of Contract (GCC) will apply and where the conditions in the special conditions of contract contradicts the conditions in the general conditions of contract, the special conditions of contract will prevail.

6. PAYMENT TERMS

- 6.1 The DFFE / MLRF undertakes to pay out in full or as per deliverables within 30 (thirty) days all valid claims for work done to its satisfaction upon presentation of a substantiated claim and the required reports stipulated in special conditions. No payment will be made where there is outstanding information/work not submitted by the Service Provider/s until that outstanding information is submitted.
