1. PURPOSE

- 1.1 The Department of Forestry, Fisheries and the Environment ("DFFE") / MLRF requires the Service Provider to render a 24-hour armed response to electronic intruder detection alarm systems at twelve Proclaimed Fishing Harbours and the Paarden Eiland Office in the Department of Forestry, Fisheries and the Environment for a period of (12) Months. The service provider will be required to have a response time of less than ten (10) minutes, seven (7) days a week including weekends and public holidays for a period of 12 months.
- 1.2 The Proclaimed Fishing Harbours and the office include the following: Lamberts Bay Harbour, Laaiplek Harbour, St Helena Harbour, Saldanha Harbour, Hout Bay Harbour, Kalk Bay Harbour, Gordon's Bay Harbour, Hermanus Harbour, Gansbay Harbour, Arniston Harbour, Struisbay Harbour and Still Bay Harbour.

2. SPECIFICATIONS

- 3.1.1 The DFFE is committed to ensure a high-performance working environment and quality of work life within a conducive environment by providing security services to secure the offices and buildings. It is crucial for DFFE to ensure that its tangible and intangible assets are secured in accordance with the Access Control to the Public Premises and Vehicle Act, 53 of 1985, Minimum Physical Security Standards (MPSS) which are applicable in the Public Service.
- 3.1.2 The scope work includes installation of intruder detection alarm systems, maintenance thereof and provision of an armed response in Proclaimed Fishing Harbours and the Paarden Eiland office to secure the tangible and intangible assets of DFFE.
- 3.1.3 Provision of a 24 hour (24) hour armed response service at identified Harbours and office, seven (7) days per week including weekends and public holidays.
- 3.1.4 Rendering a security service with duties as authorised officers in terms of the Control of Access to Public Premises and Vehicle Act, 53 of 1985.
- 3.1.5 Respond to intruder alarm system to Protect Assets, Resources and Prevent crime from occurring on premises
- 3.1.6 Recording of incidents or events in an Occurrence Register, Electronically and Report such incident or events to DFFE personnel responsible for Security Management.
- 3.1.7 Enforcing of the DFFE Security Policy
- 3.1.8 Ensure compliance with the Department of Labour Bargaining Counsil Rates
- 3.1.9 The appointed service provider will adhere to the provisions related to salaries wages and remuneration as envisaged in the provided in the bargaining counsel and the requirements as stipulated in the Labour Relations Act for a 1 x 12 hour shift as per the requirements per district or location in the table below and are as follows:

Reaction

- i. To dispatch qualified Reaction Officers to the DFFEs premises (12 Proclaimed Fishing Harbours and Paarden Eiland office) in response to an emergency call from the client, or upon receipt by the service provider of a radio transmitter signal and/or a client telephonic request to prevent or minimise the risk of loss to property, injury to persons due to fire, theft, burglary or vandalism or any other contributing factor. Records

- i. The Service Provider shall maintain accurate records relating to each intruder alarm system and provide records on request by the Departments
- 3.1.10 NB: registration with South African Intruder Detection Services Association (SAIDSA) and a valid certified copy of The Independent Communication Authority of South Africa (ICASA) is a required for provision of this service and including compliance with all relevant legislation applicable to the security environment. Registration with PSIRA is a pre-requisite. It is expected that the successful service provider should have at least 5 years' experience and undertaken a similar project in the last five years. A local footprint with a control room of at least 10/15 km from the various sites.
- 3.1.11 All service providers and technicians will be subjected to screening. The service provider shall be responsible for sourcing all alarm system parts/components/fixtures necessary in the repair and maintenance of the equipment. All the equipment's or materials used should carry the warranty or guarantee as per manufacture prescription. Replacement of equipment due to malfunctioning. The service provider shall inform the DFFE Proclaimed Fishing Harbours Management Directorate of any non-repairable equipment. Replacement equipment that would be required for critical system components.

3.2. PHASE 2: Preferential Points (80/20 system)

- 3.2.1. An evaluation of Price and Specific Goals Preference points on the suppliers, that successful qualified to this stage of evaluation.
- 3.2.2. Calculation of points for price The Preferential Procurement Policy Framework Act (PPPFA) prescribes that the lowest acceptable bid will score 80 points (for tenders under R50m) or 90 points (for tenders above R50m) for price. Suppliers that quoted higher prices will score lower points for price on a pro-rata basis. Where functionality is set as criteria, only bid proposals that meets functionality requirements will be considered for evaluation on price and specific goals preference points.
- 3.2.3. The 80/20 as an appropriate preference point system will be used in the evaluation and adjudication of this quote. However, it must be extended that the lowest acceptable quote will be used to

determine the applicable preference point system as per regulation (Section 3(2)(b) of the Preferential Procurement Regulations (PPR) 2022, which states: "If it is unclear which preference point system will be applicable, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable proposal will be used to determine the applicable preference point system". Therefore, either 80 or 90 points, depending on the rand value of the proposal, will be awarded to the suppliers who offers the lowest price, and proportionately fewer points are awarded to those with higher prices. Either 20 or 10 points are then available as preference points for Specific Goals, as applicable. The contract will be awarded to the suppliers that scores the highest total number of adjudication points per category.

Calculating of points for Specific Goals

- 3.2.4. Points will be awarded to a supplier for specific goals. Bidders are required to submit the original and valid proof for preference points claimed or certified copies thereof; to substantiate their preference points claims. SBD 6.1 must also be duly completed, signed, and submitted alongside the bid to claim preference points. Failure to do so will result in Specific Goals preference points being forfeited.
- 3.2.5. The 80/20 as an appropriate preference point system will be used in the evaluation and adjudication of this quotation. However, it must be extended that the lowest acceptable supplier will be used to determine the applicable preference point system as per regulation (Section 3(2)(b) of the Preferential Procurement Regulations (PPR) 2022, which states: "If it is unclear which preference point system will be applicable, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable supplier will be used to determine the applicable preference point system". Therefore, either 80 or 90 points, depending on the rand value of the quotation, will be awarded to the suppliers who offers the lowest price, and proportionately fewer points are awarded to those with higher prices. The SCM unit of the DFFE / MLRF will allocate preferential points (Specific Goals) to each company for its contribution towards empowerment of the black designated groups as prescribed in the Preferential Procurement Regulations of 2022, women, people with disabilities, youth as well as local economic development.
- 3.2.8. A supplier will not be disqualified from the quotation process if the suppliers does not submit supporting documents substantiating the specific goals preference points claimed or is a noncompliant contributor. Such some suppliers will score 0 for Specific Goals.
- 3.2.9. Suppliers will be subject to SCM conditions of the Department MLRF and the Preferential Procurement Regulations, 2022 issued in terms of section 5 of the Preferential Procurement Policy Framework Act (Act No 5 of 2000) (PPPFA).
- 3.2.10. The PPPFA prescribes that the lowest acceptable bid will score 80 or 90 points for price (as explained above, depending on whether the bid prices is more or less than R50million). Suppliers that quoted higher prices will score lower points for price on a pro-rata basis. Where functionality is set as a criterion, only bid proposals that meets functionality requirements will be considered to be evaluated on price and Specific Goals.
- 3.2.11. The contract will be awarded to the supplier scoring the highest points subject to section 2(1) (f) of the PPPFA, 2000.
