THE NATIONAL NORMS AND STANDARDS FOR DISPOSAL OF WASTE TO LANDFILL, 2013**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, hereby in terms of section 69(1)(a), (b), (g), (h), (m), (q), (r), (s), (dd), and (ee) read together with sections 72 and 73 of the National Environmental Management Waste Act, 2008 (Act No. 59 of 2008), give notice of the extension, by an additional 60 days, of the commenting period on the proposed amendments to the Waste Classification and Management Regulations, 2013, the National Norms and Standards for the Assessment of Waste for Landfill Disposal, 2013, and the National Norms and Standards for Disposal of Waste to Landfill, 2013, as published on 24 March 2023 in Government Notice No R. 3185 in Government *Gazette* No. 48290, Government Notice No R. 3183 in Government *Gazette* No. 48288 and Government Notice No. R R.3184 in Government *Gazette* No. 48289, respectively.

The Department of Forestry, Fisheries and the Environment received written requests for an extension of the commenting period to allow adequate time to review and provide comments on the proposed amendments and on the socio-economic impact assessment report.

Members of the public are therefore hereby invited to submit written comments and inputs to the Waste Classification and Management Regulations, 2013, the National Norms and Standards for the Assessment of Waste for Landfill Disposal, 2013, and the National Norms and Standards for Disposal of Waste to Landfill, 2013, as published on 24 March 2023 by no later than Monday, 26 June 2023, to the following addresses:
