NATIONAL FORESTS ACT, 1998 (ACT NO. 84 OF 1998)**INVITATION TO SUBMIT WRITTEN COMMENTS ON THE PROPOSED LIST OF PARTICULAR TREES AND PARTICULAR GROUPS OF TREES (CHAMPION TREES) UNDER SECTION 12(1) (A) AND (B) OF THE NATIONAL FORESTS ACT, 1998 (ACT NO. 84 OF 1998)**

I, Tshimangadzo Cyril Ndou, Director: Forest Resource Protection and in my capacity as the delegated authority hereby give notice of intention to declare a list of particular trees and a particular group of trees (Champion Trees) under section 12(1)(a)(b) of the National Forests Act, (Act No. 84 of 1998) as set out in the attached Schedule A for public comment.

The consequences of declaring a tree, species of trees or a particular group of trees or a particular woodland as protected, is set out in section 15(1) of the Act, which provides as follows:

No person may -

- (a) cut, disturb, damage, or destroy any protected tree; or
- (b) possess, collect, remove, transport, export, purchase, sell, donate or in any other manner acquire or dispose of any protected tree, or any forest product derived from a protected tree, except –
 - (i) under a licence granted by the Minister; or
 - (ii) in terms of an exemption from the provisions of this subsection published by the Minister in the Gazette on the advice of the Council.”

In terms of Section 13 (1) (a) of the said Act, interested and affected parties are invited to submit written comments or objections on the proposed list within 30 days of the publication of this notice.
